## CLUB RULES & REGULATIONS

### 1. Club Membership

- Membership is open to children and teenagers aged 5–17 years.
  - Every member must complete a registration form.
  - Parent/guardian consent is required for all members below 18 years.

### 2. Activities of The Kids & Teenagers Club

1. Organizing sports and physical activities for children including football, basketball, swimming, athletics, skating, and indoor games.
2. Conducting fun learning activities, educational games, reading sessions, and talent development programs.
3. Organizing kids' tours, picnics, camps, competitions, and recreational events.
4. Promoting creativity through music, dance, drawing, painting, drama, and other arts activities.
5. Conducting child development and life skills programs to promote discipline, confidence, teamwork, and leadership.
6. Organizing gaming and entertainment activities in a safe and child-friendly environment.
7. Providing mentorship and moral education programs for children.
8. Conducting charity and community support activities including support to vulnerable children and visits to children's centers.
9. Promoting health, fitness, safety awareness, and environmental conservation among children.
10. Organizing birthday events, holiday programs, and special children entertainment activities.
11. Collaborating with parents, schools, sponsors, and other organizations for the welfare and development of children.
12. Carrying out any other lawful activities related to children's growth, recreation, education, and wellbeing.

### **3. Registration and Fees**

- Every member shall pay a one-time registration fee of TZS 50,000.
- Every member shall pay a monthly membership fee of TZS 50,000.
- Every member shall also pay a uniform fee of TZS 35,000.
- Fees must be paid within the time communicated by the club management.

---

### **4. Contributions for Activities and Events**

- Members shall contribute additional amounts for special activities, events, tours, competitions, transport, and meals.
- The contribution amount for each session or event shall be communicated to parents/guardians before the activity date.
- Participation in certain activities may depend on timely payment of the communicated contribution.

---

### **5. Discipline and Behavior**

- Members must respect fellow members, leaders, coaches, and parents.
- Fighting, bullying, abusive language, or discrimination is strictly prohibited.
- Members must behave responsibly during all club activities.

---

### **6. Attendance**

- Members are encouraged to attend activities regularly and on time.
- Repeated absence without communication may affect participation in club activities.

---

### **7. Dress Code**

- Members must wear the official club uniform or appropriate sportswear during activities and events.
- Members are expected to maintain cleanliness and proper appearance.

---

### **8. Safety Rules**

- Members must follow instructions given by club leaders, coaches, and supervisors.
- No member shall leave an activity venue without permission.

- Any injury, illness, or accident must be reported immediately.

## **9. Child Protection**

- The club is committed to providing a safe, supportive, and friendly environment for all children.
  - Harassment, violence, intimidation, or abuse of any kind is strictly prohibited.
  - All members and leaders shall treat one another with dignity and respect.

## **10. Use of Club Property**

- Members must take care of club equipment, uniforms, and facilities.
  - Intentional damage to club property may result in disciplinary action or compensation.

## **11. Club Activities**

The club may organize:

- Sports and games
- Educational tours
- Gaming activities
- Talent development
- Charity and community programs
- Competitions and mentorship sessions

Members are expected to participate positively and responsibly.

## **12. Discipline Measures**

Failure to follow club rules may result in:

- Warning
- Suspension
- Termination of membership

depending on the seriousness of the misconduct.

### **13. Authority of Club Management**

Club leaders and coordinators shall have authority to:

- supervise activities,
- enforce discipline,
- communicate schedules and contributions,
- ensure safety and proper conduct.

### **14. Amendment of Rules**

The club management reserves the right to amend these rules when necessary for the improvement of the club.
